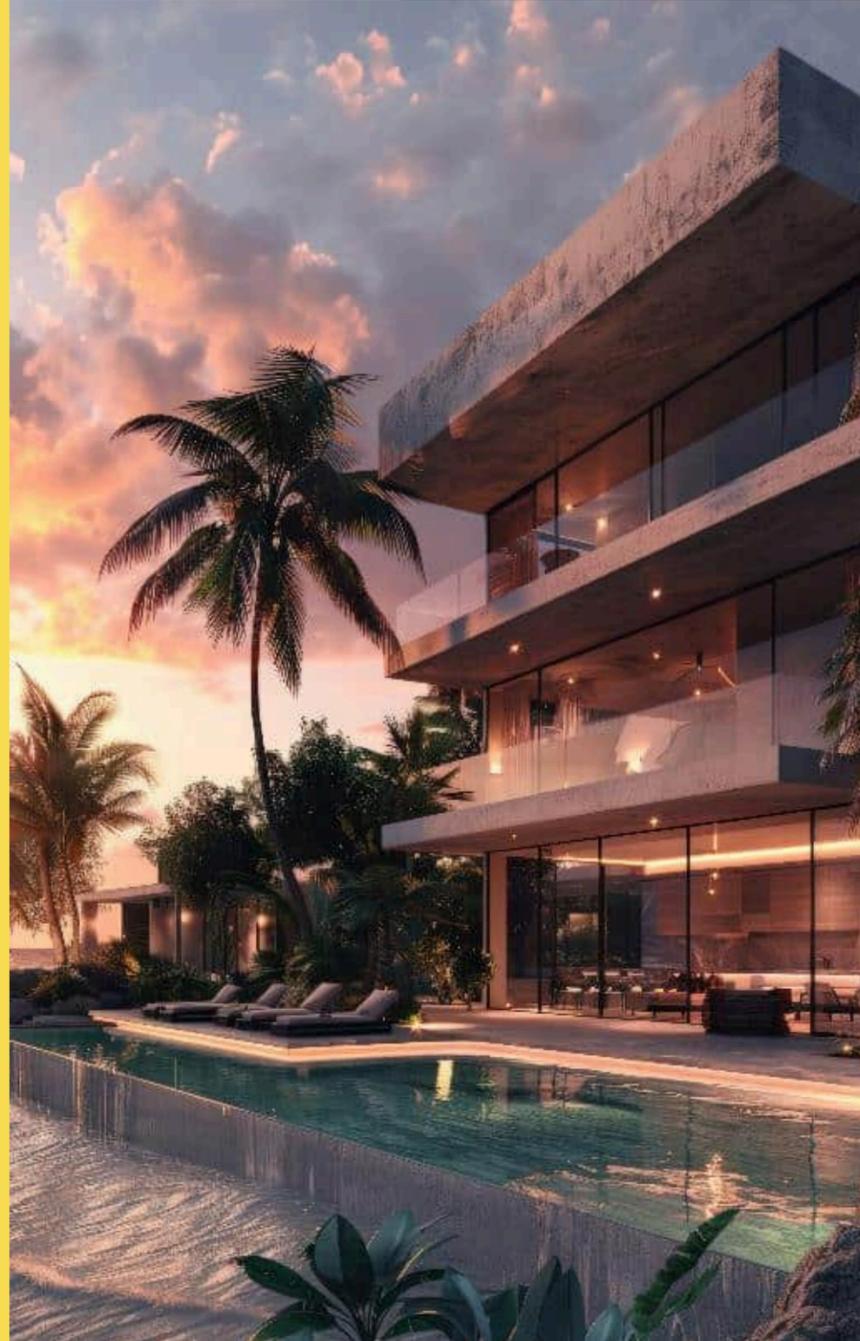

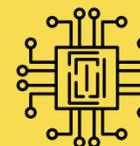

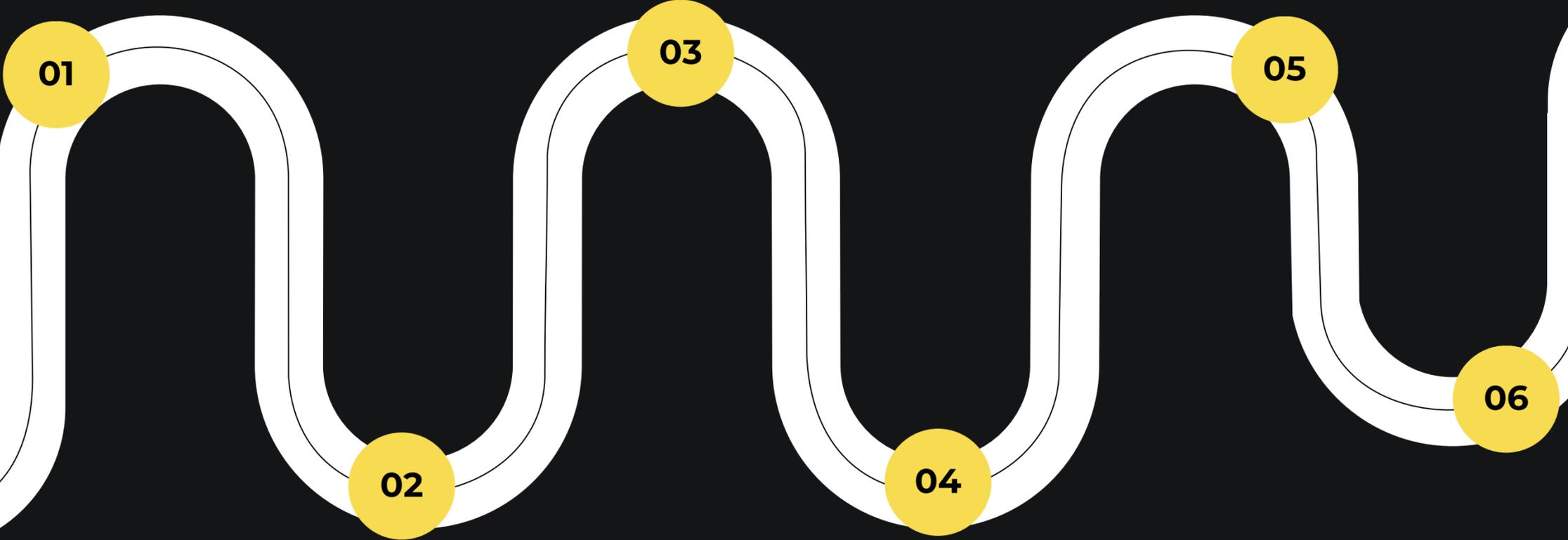

Not focusing enough on the location - It's all about the location in Dubai! Prime areas close to schools, hospitals, public transport and business hubs hold value better and rent faster.

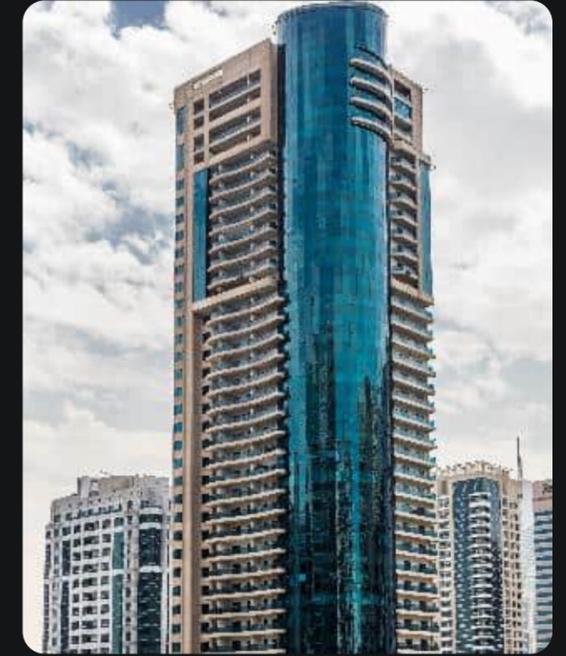

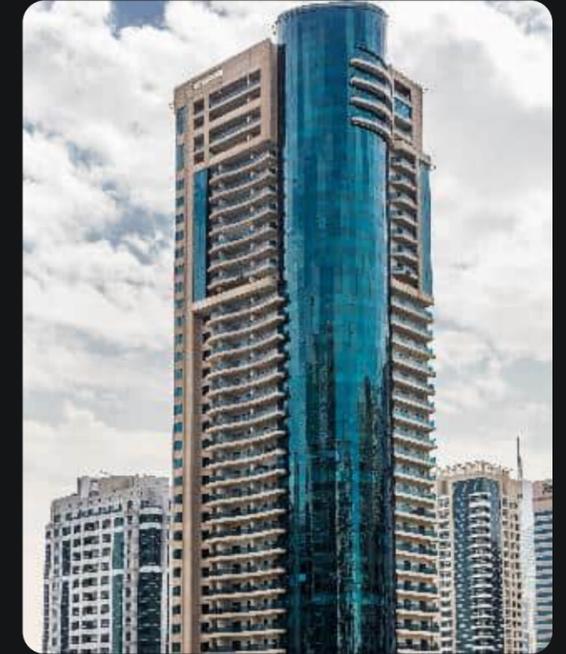

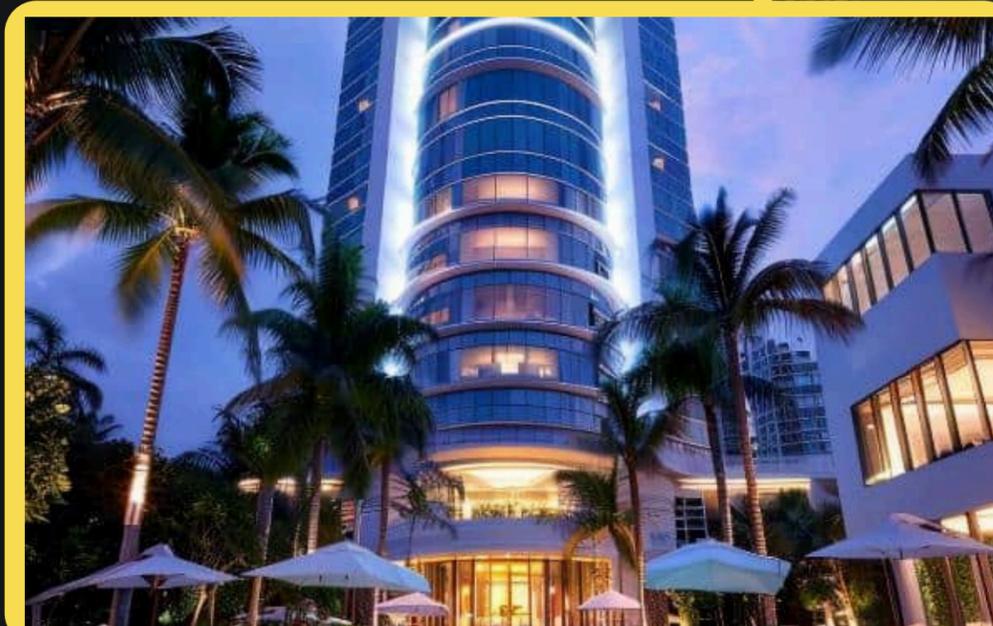
